

Harrison County Board of Review

May 17, 2018 Minutes

The Harrison County Board of Review convened in the Harrison County Courthouse, Assessor's Office at 8:00 a.m. on May 17, 2018. Meeting Agenda was noted for 2018 Final Session. Meeting notice was posted May 7, 2018.

Those in attendance were:

Moved by Roberts, seconded by Lightwine, to approve the agenda as written. Motion carried.

Moved by Boustead seconded by Lightwine, to approve the minutes from May 1, 2018 as written. Motion carried.

With no open issues to consider the board proceeded. The next item of business was to consider those petitions filed April 2nd until April 30th.

The following petitions were considered and acted upon:

Petition #2018-002

The petition of Diana Roberts, W. David Robert representative; concerning the property described as W 46' Lots 9 & 10, town of Missouri Valley was read by the board. An oral hearing was requested upon the petition. Mr. Roberts kept the oral hearing appointment & addressed the Board at 8:15 a.m. All grounds of the petition were considered. After open discussion and ample consideration by all it was moved by Lightwine, seconded by Boustead, that the petition is denied for all grounds. Motion carried. Unanimous vote.

The Board thereupon acted upon protests remaining for their consideration, and the board of review of Harrison County, holding its final session at the Harrison County Courthouse in the city of Logan, Iowa, offered the following Resolution, which was unanimously passed and adopted.

BE IT RESOLVED that all raises of assessments by the Board of Review appearing upon the lists heretofore otherwise acted upon since the dates of said posting, be, and they are, respectfully approved and confirmed and ordered to be noted in both the record of this Board, and in the Office of the Harrison County Assessor at Logan, Iowa, as the final assessment in each instance,

BE IT FURTHER RESOLVED that action taken on each and every protest where reductions are made are hereby approved and confirmed, and

BE IT FURTHER RESOLVED that there being no further business to come before this local Board of Review, all protests to the Board not having been heretofore acted upon by this local Board, in any, are hereby denied, and
