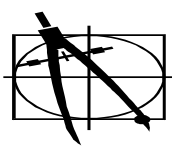

RE: DUST CONTROL PERMITS

Harrison County Road Department keeps a Dust Control Permit on file for each location where dust control has been applied. This allows for proper preparation and maintenance of the treated area. The annual permit fee is \$25.00 and is included in the contractor fee.

Jerico Services/Husker Chem Sales from Weeping Water, NE and Heffron Services from Van Meter, IA are approved contractors used by Harrison County for Calcium Chloride or Magnesium Chloride application.

The County does not endorse any specific supplier. However, any material applied for dust control must have prior approval from this office. You should contact the supplier directly to arrange for treatment of the permitted area. The telephone number for Husker Chem is 800-422-4820. The telephone number for Heffron Services is 515-321-5033. The cost of the dust control application is between you and the contractor.

We, the undersigned, hereby make application to Husker Chem Sales to apply a chloride based solution for the purpose of dust suppression in the described location. The Applicant agrees to the following:

1. **DEADLINE FOR SIGN-UP IS May 1st.** Cost will be paid by the property owner direct to the contractor. The Harrison County permit fee is included as indicated above and Jerico Services, Inc. will forward the fee to the county.
2. To place approved flags identifying the outer limits of the area to be treated with dust suppression. **Flags must be in place by May 1st and kept visible until October 1st.** Using flags will serve to visually remind the blade operator as to the location of the treated area. Failure to identify the treated area may result in your dust control being bladed through. Neither Harrison County nor Husker Chem Sales assumes any liability if your flags are not in place. If your flags are not in place when the contractor comes to treat your spot they will center your application on your house.
3. Harrison County reserves the right to scarify and maintain as a rock road any portion of the treated area that in the opinion of the county engineer has become a liability to the general public due to chuck holes, edge ruts, etc. Harrison County does not warrant nor will we pay to place dust suppression. All dust suppression is subject to blading after **October 1st** in preparation for winter.

Note: Neither Harrison County nor Husker Chem Sales can assure proper maintenance and application unless flags or stakes are in place on both sides of the road way and at both ends of the area to be treated. This helps both the blade operator and our driver understand where you want your dust suppression.

- **APPLICATIONS MUST BE RECEIVED IN OUR OFFICE BY MAY 1st.** Late applications will not be accepted.
- Applicant agrees to maintain flags to mark outer limits of the area to be treated. **Flags must be in place MAY 1st until October 15th** for the County and our drivers. Failure to do this could result in the area being bladed. Neither the County nor Heffron Services assume any liability if your flags are not in place. If area is not marked, drivers will use their judgment for location.
- Our trucks are equipped with computer equipment that allows us to spray the exact amount of footage ordered. If your flags are set longer than the footage paid for, your dust control will not reach both flags. If your flags are set shorter than the footage paid for, your dust control will extend past your flags.
- The county reserves the right to blade the treated area to maintain the public safety or in the event of rain. Your road will be bladed after October 1st in preparation for winter.
- Heffron Services, Inc. does not guarantee the performance of the product due to factors such as weather, surface preparation or heavy traffic patterns.
- Please include payment with this application. We will not cash your check until the first application is applied.
